FEATURES

- More effective in illuminating the path of egress than traditional ceiling or wall mounted emergency lights.

- UL listed for a minimum run-time of 90 minutes.

- Universal back box can be pre-shipped for pre-installation at job-site.
- Can be painted or wallpapered to seamlessly blend with architecture.
- Uses three high-output white LEDs with just 11 Watts of total load and an output of 311 lumens.
- Up to 50.0' on center spacing in a 4' wide path of egress.
- Optional infrared hand-held remote control testing can be ordered separately.
- Modular assembly and quick connector wiring.
- Line latch prevents unnecessary discharge of battery during installation.
- Brownout sensing ensures emergency operation during periods of low line voltage.
- Low voltage cut-off prevents battery damage and ensures positive charge acceptance following an extended discharge.
- Fully automatic operation.
- Battery diagnostics come standard on all units.
- Soft start, solid state, microprocessor controlled circuitry for soft close doors.
- 120/277 VAC with field selectable inputs.
